

- 2- No noise shall be audible beyond the area under the control of the licensee(s) as defined on the ABC-257
- 3- The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
- 4- The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
- 5- Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257, dated
- 6- The exterior of the premises shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the premises. Additionally, the position of such lighting shall not disturb the normal privacy and use of any neighboring residences.




