DIRECTOR'S RECOMMENDATION: APPROVE THE TERMINATION OF LEASE AGREEMENT FOR THE BOARDING AREA "F" PHARMACY, HEALTH, AND BEAUTY STORE LEASE NO. 08-0133 WITH BUTH-NA-BODHAIGE, INC. DBA THE BODY SHOP, AND DIRECT THE COMMISSION SECRETARY TO FORWARD THE TERMINATION OF LEASE AGREEMENT TO THE BOARD OF SUPERVISORS FOR APPROVAL.

Executive Summary

Buth-na-Bodhaige, Inc. dba The Body Shop ("The Body Shop") currently operates the Boarding Area "F" Pharmacy, Health, and Beauty Store Lease No. 08-0133 ("Lease") at San Francisco International Airport ("Airport"), which expires on April 7, 2016. The Body Shop has expressed a desire to terminate the Lease early and the Airport is agreeable to such an early termination provided that The Body Shop pay an early termination fee and comply with such other terms and conditions as set forth in the Termination of Lease Agreement. Staff seeks the Airport Commission's ("Commission") approval of the Termination of Lease Agreement whereby The Body Shop would pay \$198,166.23 in exchange for an early lease termination date of March 31, 2015. Staff is confident that the early termination will not result in loss of revenue because the Airport will be able to re-tenant the lease space through a competitive request for proposals process in the nine-month period after the proposed early termination date during which the Airport is receiving the equivalent of monthly rent paid in the form of the early termination fee.

Background

On July 1, 2008, the Commission adopted Resolution No. 08-0133, awarding the Boarding Area "F" Pharmacy, Health, and Beauty Store Lease ("Lease") to Harmony Pharmacy and Health Center, Inc.

("Harmony"). The Lease had a term of five years with a single two-year option to extend exercisable at the sole discretion of the Commission. On May 21, 2013, the Commission adopted Resolution No. 13-0126, consenting to the assignment of the Lease from Harmony to The Body Shop and the Commission exercised its option to extend the term of the Lease through April 7, 2016.

On November 21, 2014, The Body Shop notified the Airport of its desire to terminate the Lease prior to the lease expiration date of April 7, 2016. The Body Shop proposed an early termination date effective March 31, 2015 and has agreed to pay an early termination fee in the amount of \$198,166.23. This amount is equal to nine months of the Minimum Annual Guarantee rent, prorated on a monthly basis. Staff is confident that through a competitive request for proposals process a new tenant can be identified to enter into a new lease for the concession space between the time of proposed early termination date of March 31, 2015 and December 31, 2015 – the date through which the Airport will have received the equivalent of monthly rent from The Body Shop paid in the form of the early termination fee.

The Body Shop has agreed to a Termination of Lease Agreement, which stipulates that the Lease would terminate as of March 31, 2015 ("Termination Date") upon payment of the early termination fee of \$198,166.23. The Termination of Lease Agreement shall not relieve The Body Shop of its payment obligations under the Lease, including payment of rent, accruing prior to the Termination Date.

Proposal

Staff recommends that the Commission approve the Termination of Lease Agreement with Buth-na-Bodhaige, Inc. dba The Body Shop. Staff is confident that a replacement tenant will be identified by undergoing a competitive request for proposals process without loss of revenue to the Airport.

Recommendation

I recommend that the Commission adopt the attached resolution approving the Termination of Lease Agreement for the Boarding Area "F" Pharmacy, Health, and Beauty Store Lease No. 08-0133 with Buth-na-Bodhaige, Inc. dba The Body Shop, and direct the Commission Secretary to forward the Termination of Lease Agreement to the Board of Supervisors for approval pursuant to Section 9.118 of the City Charter.


