8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Antionette Spears v. City and County
11 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-12-527288 by the
12 payment of \$200,000.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 December 19, 2012, and the following parties were named in the lawsuit: Plaintiff: Antionette
15 Spears and Defendants: City And County Of San Francisco and the Regents Of The State Of


