NOTICE IS HERBEY GIVEN that on March 27, 2015, at 9:30 a.m., in the Mayor's Office of Housing and Community Development, 1 South Van Ness Avenue, 5th Floor, San Francisco, CA 94103, the City and County of San Francisco (the "City") will conduct a public hearing (the "Public Hearing") at which time the City will hear and consider information concerning the proposed sale and issuance by the City of multifamily affordable housing mortgage revenue City of multifamily affordable housing mortgage revenue bonds (the "Bonds") in an aggregate principal amount not to exceed Twenty One Million dollars (\$21,000,000). A portion of the proceeds of the Bonds will be loaned to Bay Street, L.P. (or any successor thereto) (the "Borrower"), pursuant to a loan agreement (the "Loan Agreement"). The proceeds of the Bonds loaned to the Borrower will be used to finance the rehabilitation of 50-unit residential rental finance the rehabilitation of a 50-unit residential rental housing development located at 227 Bay, San Francisco, California 94133 (the "Project"). The Project will be owned and operated by Bay Street, L.P. [the Borrower].

The Bonds will be paid entirely by the Borrower from the revenues of the Project, in accordance with the Loan

Neither the full faith and credit nor the taxing ower of the City, the State of California (the "State") or any other political corporation, subdivision or agency of the State is pledged to the payment of the principal, premium, if any, or interest on the Bonds, nor shall the City, the State or any other political corporation, subdivision or agency of the State be liable or obligated to pay the principal, premium, if
