Ordinance amending the Administrative Code to change the composition of the Family

Violence Council; and establishing a sunset date for the Council, unless it is

reauthorized by an Ordinance.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Chapter 5, Article XIX of the Administrative Code is hereby amended by

revising Sections 5.190 through 5.190-5, and adding Sections 5.190-6 and 5.190-7, to read as follows:

ARTICLE XIX:

FAMILY VIOLENCE COUNCIL

Sec. 5.190. Establishment and Purpose - Family Violence Council.

Sec. 5.190-1. Family Violence Council – Duties.

Sec. 5.190-2. Steering Committee – Composition – Terms of Office.

Sec. 5.190-6. Family Violence Council and Steering Committee – Support, Staffing, and Assistance.

SEC. 5.190. ESTABLISHMENT AND PURPOSE – FAMILY VIOLENCE COUNCIL.

(a) **Establishment.** A Family Violence Council for the City and County of San Francisco (referred to *hereafter* in this *Chapter <u>Article XIX</u>* as "Council") is hereby established as an advisory body to the Board of Supervisors. *The Council shall consist of representatives from City agencies, community-based organizations, academia, and the medical and business communities. All City departments, commissions, boards and agencies shall cooperate with the Council in conducting its business.*

The composition of the Council shall broadly represent the ethnic, racial, gender, age and sexual orientation diversity of the City and County.

(b) **Purpose.** The Council is established to advise and submit recommendations to the Board of Supervisors that address the problems of family violence. Family violence includes child abuse, domestic violence, and elder/dependent adult abuse. The Council may also advise the courts of the City and County and the Mayor by submitting recommendations to improve the response by *these*-departments to family violence and abuse. The general purpose<u>s</u> of the Council shall be the following:

(1) Increase the awareness and understanding of family violence (and its consequences) by establishing a series of roundtables, forums, meetings, or summits that identify, highlight, and discuss critical issues pertaining to family violence so as to broaden understanding of family violence and its causes and consequences among the public, governmental agencies, courts, and community organizations.

(2) Recommend programs and policies that promote communication and coordination of City and community-based organizations' services relating to child abuse, domestic violence, and elder/dependent adult abuse.

(3) Recommend programs, policies, and coordination of City services to the Board of Supervisors and Mayor that may reduce the incidence of family violence in San Francisco.

SEC. 5.190-1. FAMILY VIOLENCE COUNCIL - DUTIES.

The duties of the Council shall be the following:

(*I*<u>a</u>) Recommend effective strategies through which public and private agencies that serve victims of domestic or family violence can identify the existence of family violence;

(2<u>b</u>) Recommend methods of providing public education about family violence and abuse;

 $(\underline{3c})$ Facilitate communication between public and private agencies that provide programs for victims of family violence and programs of family violence intervention;

(4<u>d</u>) Recommend procedures to improve the cooperation and coordination of public and private agencies with all participants in the justice system who deal with family violence, including procedures for reviewing fatalities resulting from family violence;

 $(5\underline{e})$ Recommend a comprehensive and coordinated plan to collect data about family violence in a manner that protects the identity of victims of family violence, and that would make the data available to the courts, prosecutors, law enforcement officers, and health care practitioners;

(*ff*) Recommend ways of responding in a coordinated manner to family violence by City departments, boards, commissions, *and* agencies, and the courts that would improve responsiveness by the City and prevent family violence.;

 $(\mathcal{F}g)$ Collect, compile, and analyze public information regarding arrest and restraining order enforcement policies; screening and prosecution of cases; issuances of protective

orders; identifying family violence in other legal proceedings; *and* monitoring offenders after judgment; and other relevant data as needed;

(*8<u>h</u>*) Collect, compile, and analyze public information relating to programs for victims of family violence and services provided for abusers on probation;

(9<u>i</u>) Analyze current and projected revenue and funding sources and recommend other prospective revenue sources for response to family violence; and

(*10j*) Respond to inquiries of the Board of Supervisors made consistent with the duties imposed by this *Ordinance<u>Article XIX</u>*.

SEC. 5.190-2. STEERING COMMITTEE - COMPOSITION - TERMS OF OFFICE.

(a) **Composition of Steering Committee.** The <u>Council members serving in seats 10</u>, <u>12, and 13 shall serve as the members of the Steering Committee shall be the three and co-chairs</u> of the Family Violence Council, who shall be selected from among the members of the Family Violence Council. One co-chair will be selected from an agency or organization that specializes in domestic violence; one co-chair shall be selected from an agency or organization that specializes in child abuse; and one co-chair shall be selected from an agency or organization that specializes in elder/dependent adult abuse. A representative from the Department on the Status of Women shall provide support to the Steering Committee in scheduling meetings, developing meeting agendas, and performing such other functions as are necessary to promote the work of the Family Violence Council.</u>

(b) **Meetings.** The Steering Committee shall meet regularly at such times and places as the members of the Committee shall determine.

(c) **Rules and Regulations.** The Steering Committee may adopt reasonable rules and regulations not inconsistent with the Charter or this *Ordinance <u>Article XIX</u>* for the conduct of its affairs and for the *distribution and* performance of its business.

SEC. 5.190-3. STEERING COMMITTEE - DUTIES.

The Steering Committee shall serve as the policy setting body of the Council. Duties of the Steering Committee shall include the establishment of the organization and structure of the Council, creation of working groups when necessary to implement the objectives of the Council, and oversight of the operations of the Council.

SEC. 5.190-4. FAMILY VIOLENCE COUNCIL – COMPOSITION – TERMS OF OFFICE.

 (a) Composition. <u>The composition of the Council shall broadly represent the ethnic</u>, <u>racial, gender, age, and sexual orientation diversity of the City and County</u>. The <u>Family Violence</u> Council shall consist of the following individuals<u>or their respective designees</u>:

- (1) Presiding Judge of the Superior Court, or his/her designee;
- (2) Mayor, or his or her designee;
- (3) President of the Board of Supervisors, *or-his/her-designee*;
- (4) District Attorney, *or his/her designee*;
- (5) Chief of Police, or his/her designee;
- (6) Sheriff, or his or her designee;
- (7) President of the Commission on the Status of Women, *or his/her-designee*;
- (8) Chief of Adult Probation, *or his/her designee*;
- (9) *Chief <u>Executive Director</u>* of Department of Emergency Management, or

his/her designee;

(10) Executive Director of the Domestic Violence Consortium, or his/her

designee;

(11) Executive Director of Human Service Agency, or his or her designee;

<u>community.</u> Each of these members shall serve for a term of one-_year at the pleasure of the Steering Committee.

(b) Limitations on Service in Community-Based Organization Seats. No individual may serve as a Council member in seat 10, 12, 13, or 17, either as a named member or as a designee, for more than six years out of any nine-year period. For the purpose of calculating the number of years of service, any service prior to May 1, 2015 shall not count.

(*bc*) Assistance of the City Attorney. The <u>Council may request the</u> City Attorney's <u>Office</u> or his or her designee may be requested to provide advice and legal counsel to the Council.

(*ed*) **Meetings.** The *Family Violence* Council shall meet at least once a quarter at such times and places as the Council shall designate.

SEC. 5.190-5. FAMILY VIOLENCE COUNCIL - ORGANIZATION.

(a) **Removal of Council Members.** If a*n at-large*-member of the Council *appointed by the Steering Committee* misses three regularly scheduled meetings of the Council in any 12month period without the express approval of the Council, the Steering Committee may appoint a new *at-large* member to fill his/her seat on the Council. If a *public or private official*, *or his or her designee, who occupies an ex-officio member in* seats *1 through 24* on the Council *who has been designated by the named member to fill the seat* misses three regularly scheduled meetings of the Council in any 12-month period without the express approval of the Council, the Steering Committee may ask the *ex-officio-named* member to designate another individual to occupy that *ex-officio* seat.

(b) **Compensation.** Members of the Council shall not be compensated, nor shall they be reimbursed for expenses.

(c) Annual Report. The Council *may shall* submit an annual report of its recommendations to the Board of Supervisors, *and may present that report at a hearing at the*

<u>Board's request.</u> The Council also and may submit recommendations to the courts and the Mayor. The Council may conclude that the work of the Council has been completed and request the Board of Supervisors to abolish the Council.

<u>SEC. 5.190-6. FAMILY VIOLENCE COUNCIL AND STEERING COMMITTEE –</u> <u>SUPPORT, STAFFING, AND ASSISTANCE.</u>

(a) The Department on the Status of Women shall provide support to the Council and the Steering Committee in scheduling meetings, developing meeting agendas, and performing such other functions as are necessary to promote the work of the Council.

(b) All City departments, commissions, boards and agencies shall cooperate with the Council in conducting its business.

SEC. 5.190-7. FAMILY VIOLENCE COUNCIL - SUNSET.

Unless the Board of Supervisors by ordinance extends the term of the Family Violence Council, this Article XIX shall expire by operation of law, and the Committee shall terminate, on May 1, 2018. After that date, the City Attorney shall cause this Article to be removed from the Administrative Code.

Section 2. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal

LEGISLATIVE DIGEST

[Administrative Code - Family Violence Council]

Ordinance amending the Administrative Code to change the composition of the Family Violence Council; and establishing a sunset date for the Council, unless it is reauthorized by an Ordinance.

Existing Law

The Family Violence Council is an advisory body that makes recommendations to the Board of Supervisors, the Mayor, the Superior Court, and City departments regarding prevention and treatment of child abuse, domestic violence, and elder/dependent adult abuse. Among other duties, the Council recommends strategies to serve survivors of family violence, recommends methods of educating the public about family violence, compiles relevant data, and facilitates communication and cooperation between public and private agencies.

The Council has 18 designated seats: 14 local government officials or their designees and the heads of four community-based organizations or their designees. Three of the members representing community-based organizations serve as the co-chairs of the Council and also serve as the members of the Steering Committee, a three-person committee that sets policy for the Council. The Steering Committee has discretion to appoint three additional members to the Council.

Amendments to Current Law

The proposed ordinance would add six seats to the Council, to be filled by the following City officials or their designees: Chief of Juvenile Probation; Public Defender; Director of the Department of Animal Care and Control; Superintendent of San Francisco Unified School District; Human Resources Director; and Chief of the Fire Department. The ordinance would also provide that the Board of Supervisors could temporarily appoint an individual to fill a seat whenever one of the seats designated for a non-City representative remains empty for 60 days or longer.

The ordinance would clarify that the co-chairs of the Council and members of the Steering Committee would be the representatives from the Domestic Violence Consortium, the Consortium for Elder Abuse Prevention, and the San Francisco Child Abuse Council.

The ordinance would set limits on the service of individuals representing community-based organizations on the Council. Starting in May 2015, no individual could serve as a Council member representing a community-based organization for more than six years out of any nine-year period.

The ordinance would also set general criteria for the appointees in the three additional Council seats appointed by the Steering Committee.

Under Board of Supervisors Rules of Order, Rule 2.21, the ordinance would also provide that the Council will automatically sunset on May 1, 2018 unless extended in a subsequent ordinance.

Board of Supervisors Rules of Order 2.21 establishes certain criteria that must be included in legislation creating and establishing, or reauthorizing, new bodies (boards/commissions/task forces/advisory bodies) and requires the Clerk of the Board to advise the Board on certain matters. In order to fulfill these requirements, the following is provided:

File No. 150083 Family Violence Council

This Ordinance changes the composition of the existing Family Violence Council and establishes a sunset date.

Does a current body address the same or similar subject matter?

No current body addresses the same or similar subject matter.

Language requiring the body to meet at least once every four months

Section 5.190-4(d) states that the Council shall meet at least once every quarter.

Language indicating members serve at the pleasure of the appointing authority

The composition of the Council consists mostly of specific department heads, or his/her designee, who are not appointed. Section 5.190-4(a) allows the Steering Committee, which is made up of three Council members, to appoint up to three additional members to the Council and these members shall serve at the pleasure of the Steering Committee.



Language establishing attendance requirements

Section 5.190-5(a) states that members appointed by the Steering Committee may be removed by the Steering Committee if they miss three meetings in any one year period. If members are designated by a department head in any of the other seats and miss three meetings in one year, the Council may request that department head designate another individual.

Number of seats and qualifications

There are 24 seats consisting of specific department heads, or his/her designee, and the possibility of up to three additional members appointed by the Steering Committee.

Term limits (i.e., commencement date? staggered terms?)

Section 5.190-4(b) states that Council members in seats 10, 12, 13, or 17 can only serve for six years out of a nine-year period. Section 5.190-4(a) states that members who are appointed by the Steering Committee serve for one year. The terms for the remaining members are not specified since the seats are specific to a department head, or his/her designee.

Administering department

The Department on the Status of Women shall provide support to the Council.

Reporting requirements

Section 5.190-5(c) states that the Council shall submit an annual report of its recommendations to the Board of Supervisors. The Council may also submit recommendations to the courts and the Mayor.

Sunset date

Section 5.190-7 terminates the Council on May 1, 2018, unless the Board of Supervisors extends the term by Ordinance.
