MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated person to serve as a member of the Energy Efficiency Coordinating Committee, pursuant to the provisions of Administrative Code. Sections 5.90-5.96, for the term specified:

Antonio Diaz (residency requirement waived), seat 2, new appointment, must be recommended by a community-based organization that deals primarily with environmental justice, for a one-year term to be determined based on the date of the first inaugural meeting.

FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the Energy Efficiency Coordinating Committee has a goal to be representative of the diversity of the City and County of San Francisco.
- 2. Applicant Antonio Diaz, who is not a resident of San Francisco, is a person with experience that uniquely qualifies him to serve on the Energy Efficiency Coordinating Committee.
- 3. The Energy Efficiency Coordinating Committee has attempted to fill the position, for which Antonio Diaz was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Antonio Diaz is qualified to serve on the Energy Efficiency Coordinating Committee.
- 4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco, and who has the

specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Energy Efficiency Coordinating Committee at this time; and, be it FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Antonio Diaz, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Charter, Section 4.101(a)(2), that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
