17 WHEREAS, Under Administrative Code, Section 5.122(a), the Board of Supervisors
18 has the authority to reject the appointment by a two-thirds vote (eight votes) within thirty days
19 following transmittal of the Mayor's Notice of Appointment, and the failure of the Board to
20 reject the appointment by two-thirds vote within the thirty-day time period shall result in the
21 appointee continuing to serve as appointed; now, therefore, be it
