



Poverty in San Francisco and Project 500

- Despite economic growth, over 236,000 SF residents still struggling financially.
- Project 500: Mayor Lee has committed to Project 500, which will bring intensive resources, wrap-around services and case management across City departments for at least 500 of the most at-risk families, to give them meaningful pathways up and out of poverty.








Health Care / Food Security

- Medi-Cal has added more than 90,000 individuals in SF since January 2014, reaching nearly 170,000 people across more than 111,000 cases by February 2015 and CalFresh continues to grow, although many eligible clients remain unenrolled
- HSA has moved to integrate Medi-Cal and CalFresh eligibility work to create efficiencies
- Challenges remain:

- While many calls are answered within a few minutes, clients may still experience 30+ min plus wait times and ~15% of callers hang up
- During ACA open enrollment, clients had average wait times of 30-40 minutes at HSA lobbies


Families: CalWORKs

- CalWORKs has implemented program changes and service expansions passed by the Legislature in FY13-14 and FY14-15:
- Standardized Assessments
- Family Stabilization
- Subsidized Employment / JobsNow!
 - 832 CalWORKs clients have been placed in subsidized jobs this year
 - 114 of those are placed in private sector jobs, with an average wage of \$14.58
- Housing Subsidies
 - Through April, new \$2M Housing Subsidy Program has provided 66 homeless families with ongoing rental subsidies

Single Adults: CAAP


- CAAP caseloads have declined with the economic recovery
- However, many CAAP clients still face substantial barriers to self-sufficiency
- HSA continues to re-work its CAAP program design to keep clients
 - eligible and housed
 - while they work toward employment
 - or **SSI** eligibility.


- Opened the pilot Navigation Center in late March
 - Mayor has committed to additional units of supportive housing and HSA is exploring masterlease sites at the Baldwin House (186 units) and Henry Hotel (126 units) as well as short-term placements at the Civic Center Hotel (156 units)
 - Received federal McKinney funding to cover some costs of the Baldwin House project

Department of Aging and Adult Services IHSS Division

- In-Home Support Services (IHSS) pays for non-medical, home-based care for disabled and elderly individuals at risk of institutionalization.
- Current caseload: 22,556
 - 73% seniors


- 40% live alone

Adult Protective Services: Investigated Allegations and Substantiated Abuse by Most Common Types of Abuse






