10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. Findings. The San Francisco Public Utilities Commission desires to settle

13 **Thomas, et al.**, San Francisco Superior Court, Case No. CGC-10-502809 by the payment of
14 \$49,486 by Donnie Thomas, \$134,729 by Miles Bonner, \$10,000 by John Rausch and \$6,319
15 by Vincent Padilla, for a total payment by Defendants of \$200,534. The above-named action
16 was filed in San Francisco Superior Court on August 19, 2010, and the following parties were
17 named in the lawsuit: Defendants Donnie Thomas, Miles Bonner, John Rauch, Robert
18 Mazariegos, Vincent Padilla, Elizabeth Bradford, Centennial Distributors, Inc., Carlos Quiroz,
19 Jean Quiroz.
