Dear Supervisors Avalos, Cohen, and Tang:

I'm writing this letter in support of Jane Tobin as a candidate for the **Commission of Animal Control and Welfare.**

I have worked as Jane's colleague on the board of Friends of San Francisco Animal Care & Control (Friends of SFACC) for the past 5 years as co-president of that nonprofit organization. We have collaborated closely during that time on a wide variety of projects to support the mission of SFACC, which extends to the residents of San Francisco, their pets, and the wildlife in the City.

Jane's service on the Friends of SFACC board began at its inception in 2000, and she has committed the past 15 years to establishing relationships with ACC leadership, with the animal welfare community (through ACC's rescue partners), and with SF residents, through community programs. Jane envisioned a number of programs that, through funding by Friends of SFACC, were implemented and still serving the public and animals. One example is the Microchip and Low-cost Rabies Clinic—a program that works in cooperation with ACC and San Francisco Veterinary Medical Association (SFVMA). SF residents, are required by law to vaccinate their dogs against rabies (for the dog as well as the public health impact). Dog owners are also required to license their dogs. Jane realized that some residents can't afford a regular vet visit (for the rabies vaccine) but they can afford a \$6 vaccine. By subsidizing the vaccine at ACC, the clinic provides the convenience and affordability of both license and vaccine, with the added bonus of a free microchip for SF dogs and cats, which identifies lost animals. Fewer strays in the shelter is beneficial to the City as well. The clinic operates five times a year and is attended beyond capacity each time. It fills a huge need, providing multiple benefits to people and animals. The success of the Microchip/Rabies Clinic is one example of Jane's ability to analyze community need and come up with a solution that benefits all the stakeholders. In addition documenting the details of how to implement the clinic, Jane coordinated volunteer vets, vet techs, and shelter volunteers and worked at the clinics herself. She is the first one to roll up her sleeves!

Besides program development, under Jane's leadership the Friends of SFACC has grown, in both community visibility and funding capacity. The general public often misunderstands the work of open-door shelters, and under Jane's guidance and direct efforts, community sponsors have taken notice of ACC's work and public services. Friends of SFACC projects have helped increase public awareness of ACC,

through sponsored community events and communications (newsletters and other mail campaigns). In recent years, Friends funding has increased by over 500%, an achievement that allowed the department to expand behavior and training resources for animals. The increase in funding capacity has allowed Friends to establish a special medical fund for animals who need medicines or surgery that are beyond basic care provided by the City.

Jane Tobin's work is notable. She has a tireless work ethic and is extremely adept at analyzing the perspectives and needs of different groups, as well as creating policy and coordinating every detail of a fundraising event. Her collaboration skills are exemplary, and her sense of humor in stressful circumstances has made working with her a pleasure. Jane never loses sight of the fact that SF/ACC faces extraordinarily challenging situations every day, as all animal welfare organizations do. She would bring many valuable qualities to the Commission.

Business and/or professional experience:

In 2009, I interned with the Humane Society of the United States in their farm animal welfare division, fact-checking publications on farm animals, factory farms, food safety, and environmental and public health. In 2010-2011, I worked in the legal department of the Foundation to Support Animal Protection, preparing comments and complaints to government agencies asking them to enforce animal welfare and animal cruelty laws. I also wrote a policy analysis of mandatory spay/neuter laws for my master's capstone for USF's Master of Public Affairs program. Last year, I worked for Supervisor Jane Kim's re-election campaign as campaign manager and treasurer. And I am currently working for the Animal Legal Defense Fund in the legislative affairs department, helping to pass legislation that protects animals, fighting legislation that would harm animals, and setting up and implementing the organization's national Do Not Adopt Database of animal cruelty convictions, which would give shelters, rescue groups, pet stores, and individuals an additional tool to screen potential adopters/customers and ensure animals are not adopted/sold to people who have been convicted of animal cruelty.

Civic Activities:

In 2010-2011, I volunteered with PETA's Community Animal Project, delivering straw bedding, toys, treats, water, and love to forgotten dogs in deeply impoverished areas of southeastern Virginia and improved their quality of life by cleaning trash and animal waste from their yards and fenced-in enclosures. In 2012-2014, I volunteered at Animal Care & Control as a dog walker and was part of their former Green Dog Program, working with dogs who needed extra training and enrichment while they were awaiting adoption. Last year, I was a Corner Captain Volunteer with Tenderloin Safe Passage, standing at high-crime corners in the Tenderloin and helping youth get to their afterschool programs and homes safely. Currently, I volunteer for the District 6 Democratic Club, helping to promote their public events/panels, expand club membership, and help people learn about and become more engaged in the San Francisco political process.

I was born and raised in San Francisco and currently live in Mission Bay. I attended public schools, including Lowell High School and City College of San Francisco. I am also attaching my resume, which explains my background and qualifications.

I have served on the Animal Control and Welfare Commission since June of last year, actively participating in discussions on a wide range of animal welfare topics the Commission has considered this past year, including hiring the new director of Animal Care & Control, supporting a statewide ban on the sale of ivory, the San Francisco Police Department's shooting of pit bulls, the Commission's presence on social media, and living in harmony with coyotes. I also presented my own research on local mandatory spay/neuter laws to the Commission for discussion on whether mandatory spay/neuter is appropriate for San Francisco.

If reappointed to the Commission, I would like to continue working with Animal Care & Control to help relieve the burden on the Department from companion animal overpopulation and animal cruelty. Board Qualifications:

The Commission of Animal Control and Welfare consists of eleven (11) members.

The seven (7) members appointed by the Board of Supervisors shall be voting members: > Six (6) members shall represent the general public and have interest and experience in animal matters; and

> One (1) member must be a licensed veterinarian practicing in San Francisco.

The other four (4) members are non-voting members, as follows:

> One (1) member shall consist of the Director of the Animal Care and Control Department or his/her designated representative;

> One (1) member appointed by the Director of the Department of Public Health or his/her designated representative;

> One (1) member appointed by the Chief of Police or his/her designated representative; and
 > One (1) member appointed by the General Manager of the Recreation and Park Department or his/her designated representative.

Each member of the Commission of Animal Control and Welfare of the City and County of San Francisco shall be a resident of the City and County of San Francisco, except for the licensed veterinarian, who must practice in San Francisco, but who need not be a resident of San Francisco.

The Commission shall have the powers and duties to: a) hold hearings and submit recommendations regarding animal control and welfare to the Board of Supervisors and the City Administrator; b) study and recommend requirements for the maintenance of animals in public, private, and commercial care; and c) work with the Tax Collector, Director of the Animal Care and Control Department, and authorized licensing entities to develop and maintain dog licensing procedures and make recommendations on fees.

Term of Office: Three of the members who are first appointed by the Board of Supervisors shall be designated to serve for terms of one year and three for two years from the date of their appointment. Thereafter, members shall be appointed as aforesaid for a term of two years, except that all of the vacancies occurring during a term shall be filled for the unexpired term.
