



We respectfully request your support in obtaining a double transfer of Liquor License #21-57621 from Herbert Fong and James Kui Louie (both deceased) with the license address 736 Divisadero to Pacific Retail VFC1, Inc. (dba Vom Fass Oils Vinegars Spirits) at Ghirardelli Square, 900 North Point Street E205, San Francisco, CA 94109.

We have the Type 21 license in escrow with Capital Trust Escrow 280 S. Beverly Drive, Beverly Hills, CA 90212. We have paid all applicable fees for the transfer and all funds for purchase of the license are in escrow. The widows selling the license are in need of funds and did not even have funds to pay the renewal. We had to pay the renewal fee out of our pocket as the license was already in penalty.

Currently we are doing business as Vom Fass Oils Vinegars Spices. We are seeking to add wine and spirits to our product line with the new dba Vom Fass Oils Vinegars Spirits. We have submitted the request for the new dba with the County Clerk, paid all fees and published the public notice as required. We are in the publication period now.

The business is owned and operated by me, Michael j. Pollastro, and my wife Alaide (Adelaide) Batista Pollastro. We have been in business since August of 2013. Our hours of operation are Sunday through Thursday 10 AM until 7 pm during off-season and 10 AM until 9 PM Fridays and Saturdays year round as well as Mondays through Thursdays during peak season.
