Ordinance retroactively waiving the fee required by Public Works Code, Section 724.1(b) for temporary street space occupancy permit on certain designated City streets on Saturday, May 16, 2015, and Saturday, May 23, 2015, as part of Small Business Week Sidewalk Sales.

Existing Law

Currently, Public Works Code Section 724.1(b) requires a fee for a temporary street occupancy permit.

Amendments to Current Law

The proposed ordinance waives the permit fee on Saturday, May 16, 2015 between 7 a.m. and 9 p.m. within certain designated streets within San Francisco, and on Saturday, May 23, 2015 between 7 a.m. and 9 p.m. within certain designated streets within San Francisco as part of Small Business Week Sidewalk Sales. All other provisions of the Public Works Code, Sections 724 et seq., remain in full effect. The proposed ordinance has a retroactivity provision.
