Be it ordained by the People of the City and County of San Francisco:

Section 1. The Health Code is hereby amended by revising Section 128 to read as follows:

## SEC. 128. PATIENT RATES.

The Board of Supervisors of the City and County of San Francisco does hereby determine and fix the proper reasonable amounts to be charged persons for services furnished by the Department of Public Health as follows, which rates shall be effective for services delivered as of July 1, 2014 through June 30, 2016.

Section 2. Effective Date; Retroactivity of Rates.

- (a) This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
- (b) As Section 128 of the Health Code specifies that the patient rates set therein are effective for services delivered as of July 1, 2014 through June 30, 2016, the patient rates established in this ordinance are retroactive to July 1, 2014.

Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
