

## ORDINANCE NO.

[Settlement of Lawsuit - Marshall & Swift/Boeckh, LLC - \$395,000]

Ordinance authorizing settlement of the lawsuit filed by Marshall & Swift/Boeckh, LLC, against the City and County of San Francisco for \$395,000; the lawsuit was filed on August 1, 2014, in the U.S. District Court for the Central District of California, Case No. 2:14-CV-6029-MMM (JPRx); entitled <u>Marshall & Swift/Boeckh, LLC, dba Marshall & Swift</u> <u>v. City and County of San Francisco</u>; other material terms of said settlement are termination of San Francisco's licenses to use the Marshall Valuation Service, retroactively effective July 1, 2015.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Marshall & Swift/Boeckh, LLC, dba</u> <u>Marshall & Swift v. City and County of San Francisco</u>, Central District of California, Case No. 2:14-CV-6029-MMM (JPRx) by the payment of \$395,000 and termination of San Francisco's licenses to use the Marshall Valuation Service, effective July 1, 2015.

Section 2. The above-named action was filed in Central District of California on August 1, 2014, and the following parties were named in the lawsuit: Marshall & Swift/Boeckh, LLC, dba Marshall & Swift (plaintiff), City and County of San Francisco (defendant).
