The Planning Department has determined that the actions contemplated in 13 14 this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the 15 Board of Supervisors in File No. 150560 and is incorporated herein by reference. The Board 16 affirms this determination. 17 18 19 Section 2. The Public Works Code is hereby amended by revising Section 2.1.1, to read as follows: 20 21 SEC. 2.1.1. FEES. 22 Notwithstanding the permit fee provisions listed elsewhere in this Code, the permit fee 23 and assessment schedule for the permit categories and uses specifically listed below shall be: 24 25 Mayor Lee BOARD OF SUPERVISORS

(n) Under permit categories in Subsections (e), (g), or (h)(i), if the permit is associated with a subdivision map approval, the permit fee is \$133.20 per permit; *and*

(o) Sidewalk width change fee: \$3,875.00, with \$1,375.00 of this fee allocated to the Planning Department for its review,

(p) Nighttime work permit fee: \$115.45; and

(q) Preapplication meeting or staff consultation fee: \$404.76 for the first two hours or portion thereof and \$202.38 for each additional hour or portion thereof.

Section 3. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.
