15 2:14-CV-6029-MMM (JPRx) by the payment of \$395,000 and termination of San Francisco’s
16 licenses to use the Marshall Valuation Service, effective July 1, 2015.

18 1, 2014, and the following parties were named in the lawsuit: Marshall & Swift/Boeckh, LLC,

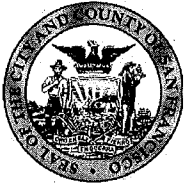
