This is to notify you that a petition signed by property owners to form a property and business improvement district in your area was received by the Clerk of the Board of Supervisors on June 2, 2015. The proposed district would be known as the Greater Rincon Hill Community Benefits District.


If this Property and Business Improvement District is formed, it would authorize assessments against real property in the district for 15 and one-half years with services to be implemented January 1, 2016, through December 31, 2030. The Greater Rincon Hill Community Benefits District would fund and provide the following services:

- 1) Public Safety
- 2) Cleaning and Maintenance
- 3) Parks and Greenspace
- 4) Communication and Development
- 5) Management

Formation of the property and business improvement district is subject to the approval of the Board of Supervisors after noticed public hearing and a vote by the property owners who would be subject to the assessments. Following public comment, ballots submitted by the property owners in the proposed Greater Rincon Hill Community Benefits District will be counted by the Department of Elections and the results will be announced by the Board of Supervisors. If the ballot election does not result in a majority protest against formation of the proposed district, the Board of Supervisors may vote to establish the Greater Rincon Hill Community Benefits District.

### 三藩市市及縣市參事委員會

茲通告三藩市市及縣市參事委員會，將舉行公聽會考慮以下提案以及有意參與所述公聽會的各方人士應出席及發表言論的時間：




