9 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby

11 San Francisco, et al.), San Francisco Superior Court, Case No. CGC-13-534052 by the  
12 payment of \$50,000.

13 Section 2. The above-named action was filed in San Francisco Superior Court on  
14 September 5, 2013, and the following parties were named in the lawsuit: plaintiff: Zaria  
15 Daskam; defendant: City and County of San Francisco.






