WHEREAS, Bruce Storrs, the City and County Surveyor, on behalf of the Department of Public Works (Public Works), in a decision dated June 9, 2015, determined that the tentative map application for a 6-unit condominium conversion at 158-162 Linda Street (Assessor's Block No. 3597, Lot No. 049) was incomplete; and

WHEREAS, His letter to the applicant states: "[t]his application is being returned at this time. If you choose to resubmit, please do so once the applicants are eligible for conversion;" and

WHEREAS, Mr. Storrs decision was not a disapproval of the tentative map itself, but rather a determination that the application was incomplete; and

WHEREAS, Said determination is on file with the Clerk of the Board of Supervisors in File No. 150638 and is incorporated herein by reference; and

WHEREAS, On July 15, 2015, Rosemarie MacGuinness of Sirkin Law APC on behalf of owner/occupants of 158 Linda Street ("Appellants") filed a timely appeal to the decision of Public Works; and

WHEREAS, Said appeal letter is on file with the Clerk of the Board of Supervisors in File No. 150638 and is incorporated herein by reference; and
