Be it ordained by the People of the City and County of San Francisco:

Section 1. The Administrative Code is hereby amended by adding Chapter 21A and Section 21A.1, and revising and renumbering (as Section 21A.2) existing Section 21.43, to read as follows:

## CHAPTER 21A. HEALTH-RELATED COMMODITIES AND SERVICES SEC. 21A.1. SCOPE OF CHAPTER.

- (a) Agreements for Commodities and Services for the Department of Public Health ("DPH") may be entered into and procured under the requirements of this Chapter 21A where expressly stated in this Chapter.
- (b) Unless expressly stated otherwise in Chapter 21A, Chapter 21, as well as any other applicable Charter or Code requirement, shall apply to Commodities and Services contracts procured by DPH.
  - (c) As used in this Chapter 21A, all words shall have the same meanings as in Chapter 21.

(b) The Director of Health ("Director") is hereby authorized to apply and pay for membership of the Department of Public Health ("DPH") in the University Health Systems Consortium UHC, and the University HealthSystems Consortium Services Corporation UHCSC, and their successors, and other entities that offer GPOs. Upon obtaining membership, DPH is authorized to utilize all programs and services provided offered by the University HealthSystems ConsortiumUHC, and the University Health Systems Consortium Services Corporation UHCSC, and their successors, and other entities that offer GPOs, including, but not limited to, the  $P_{\underline{p}}$  urchasing  $P_{p}$  rogram and the clinical and financial databases. The Director of Health is authorized to enter into and execute written *membership* agreements on behalf of the City and County of San Francisco ("City") with the *University HealthSystems Consortium UHC*, and the *University* HealthSystems Consortium Services Corporation UHCSC., and their successors, and other entities that offer GPOs. The Director of Health, or person designated in writing by the Director, is also authorized to enter into and execute written agreements, including but not limited to operating lease agreements for equipment, and execute purchase orders on behalf of the City and County of *San Francisco* with suppliers of *commodities*, *information technology products and related services*, equipment maintenance, general and professional services goods and materials, and/or finance entities affiliated with those suppliers, selected by the <u>UHC, the</u> <del>University HealthSystems</del> Consortium Services Corporation UHCSC, and their successors, or other entities that offer GPOs, through *itstheir* competitive bidding processes. Subject to applicable provisions of the City Charter, Said such agreements and purchase orders shall be governed by the GPO's terms of the University Health Systems Consortium Services Corporation's standard terms and conditions. DPH may consult with the Office of Public Finance on agreements to which a supplier's finance entity is a party.

(c) The Director shall evaluate all GPO memberships every five (5) years beginning in 2020. and provide the Health Commission with a report of such evaluation by January 31, 2020, and by January 31 of every fifth year thereafter to determine which GPO membership(s) offer DPH the best value.

Section 2. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles. numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.
