3 **Ordinance waiving the banner fees under Public Works Code, Section 184.78, for up to**
4 **twenty-five banners to be placed by Abraham Lincoln High School to publicize its 75th**
5 **Anniversary Celebration Gala.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1.

15 (a) This ordinance is uncodified.

16 (b) Findings. Abraham Lincoln High School will be celebrating its 75th Anniversary
17 with a Celebration Gala on Saturday, October 3, 2015. Abraham Lincoln High School intends
18 to post up twenty-five banners publicizing the Gala on City-owned utility poles along 19th
19 Avenue north of Sloat Boulevard, subject to approval by the Department of Public Works.


20 (c) Fee waiver. The fees set forth in Public Works Code Section 184.78 shall be
21 waived for Abraham Lincoln High School for up to twenty-five banners posted on City-owned
22 utility poles along 19th Avenue north of Sloat Boulevard beginning September 1, 2015. All
23 other provisions of Public Works Code Section 184.78 shall remain in full effect.

24 Section 2. Effective Date and Retroactivity. This ordinance shall become effective 30
25 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor
returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it,

1 or the Board of Supervisors overrides the Mayor's veto of the ordinance. However, the
2 provisions of this ordinance shall be retroactive to September 1, 2015 if the effective date of
3 the ordinance occurs after that date. If this ordinance becomes effective after September 1,
4 2015, the Board of Supervisors intends that the Department of Public Works exercise
5 administrative discretion to waive the fee during that period. Otherwise, in light of the
6 retroactivity provision above, upon the effective date of this ordinance, the Department of
7 Public Works shall be obligated to refund any excess fees collected during that time period.

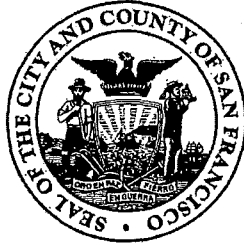


