ORDINANCE NO.

[Settlement of Lawsuit - Pacific Gas and Electric Company - City to Receive \$1,594,700]

Ordinance authorizing settlement of the lawsuit filed by the City and County of San Francisco against Pacific Gas and Electric Company (PG&E) for \$1,594,700; the lawsuit was filed on March 6, 2013, in San Francisco Superior Court, Case No. CGC-13-529310; entitled <u>City and County of San Francisco v. Pacific Gas and Electric Company</u>; other material terms of the settlement are that the City will execute a limited release of claims covered by the litigation and the City and PG&E will each bear its own fees and costs.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>City and County of San Francisco v.</u> <u>Pacific Gas and Electric Company</u>, San Francisco Superior Court, Case No. CGC-13-529310 by the payment of \$1,594,700 by PG&E and other material terms of the settlement are that the City will execute a limited release of claims covered by the litigation and the City and PG&E will each bear its own fees and costs.

Section 2. The above-named action was filed in San Francisco Superior Court on March 6, 2013, and the following parties were named in the lawsuit: The City and County of San Francisco and Pacific Gas & Electric Company.
