3 **Ordinance authorizing settlement of the lawsuit filed by Yoshio Haraguchi against the**  
4 **City and County of San Francisco for \$90,000; the lawsuit was filed on August 15, 2014,**  
5 **in San Francisco Superior Court, Case No. CGC-14-541209; entitled Yoshio Haraguchi**  
6 **v. City and County of San Francisco, et al.; other material terms of said settlement is**  
7 **payment of San Francisco General Hospital lien in the amount of \$20,000.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Yoshio Haraguchi v. City and County  
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-14-541209 by the  
13 payment of \$90,000, including \$70,000 to plaintiff and payment of a San Francisco General  
14 Hospital lien in the amount of \$20,000.

15 Section 2. The above-named action was filed in San Francisco Superior Court on  
16 August 15, 2014, and the following parties were named in the lawsuit: plaintiff Yoshio  
17 Haraguchi; defendant City and County of San Francisco.






