3 **Ordinance authorizing settlement of the lawsuit filed by Kathie Lustig against the City**
4 **and County of San Francisco for \$100,000; the lawsuit was filed on June 13, 2014, in**
5 **San Francisco Superior Court, Case No. CGC 14-539885; entitled Kathie Lustig v. City**
6 **and County of San Francisco, et al; other material terms of said settlement are Co-**
7 **Defendant PG&E will reimburse City \$50,000 as part of settlement.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Kathie Lustig v. City and County of
12 San Francisco, et al, San Francisco Superior Court, Case No. CGC 14-539885 by the
13 payment of \$100,000 and Co-Defendant PG&E will reimburse City \$50,000 as part of
14 settlement.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 June 13, 2014, and the following parties were named in the lawsuit: Plaintiff Kathie Lustig,
17 Defendants City and County of San Francisco, PG&E and Park Tavern.




