9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Thomas Mich v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC 14-542654 by the
13 payment of \$70,000 and waiver of a Department of Public Health lien of \$20,469.30.

14 Section 2. The above-named action was filed in the San Francisco Superior Court on
15 November 12, 2014, and the following parties were named in the lawsuit: Plaintiff Thomas
16 Mich and Defendant City and County of San Francisco.




