9 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Denise Green v. City and County of  
11 San Francisco, et al., United States District Court, Case No. C10-2649 by the payment of  
12 \$495,000.

13 Section 2. The above-named action was filed in the United States District Court for the  
14 Northern District of California on March 30, 2009, and the following parties were named in the  
15 lawsuit: Plaintiff Denise Green and Defendants City and County of San Francisco and  
16 Sergeant Ja Han Kim.




