ORDINANCE NO.

[Settlement of Lawsuit - Yoshio Haraguchi - \$90,000]

Ordinance authorizing settlement of the lawsuit filed by Yoshio Haraguchi against the City and County of San Francisco for \$90,000; the lawsuit was filed on August 15, 2014, in San Francisco Superior Court, Case No. CGC-14-541209; entitled <u>Yoshio Haraguchi</u> <u>v. City and County of San Francisco, et al.</u>; other material terms of said settlement is payment of San Francisco General Hospital lien in the amount of \$20,000.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Yoshio Haraguchi v. City and County</u> <u>of San Francisco, et al.</u>, San Francisco Superior Court, Case No. CGC-14-541209 by the payment of \$90,000, including \$70,000 to plaintiff and payment of a San Francisco General Hospital lien in the amount of \$20,000.

Section 2. The above-named action was filed in San Francisco Superior Court on August 15, 2014, and the following parties were named in the lawsuit: plaintiff Yoshio Haraguchi; defendant City and County of San Francisco.
