WHEREAS, Michael Scott Reigle was born in Lincoln, Nebraska on October 12, 1973, attended Lincoln Southwest High School, and graduated from the University of Nebraska with a degree in International Business and Finance; and

WHEREAS, Mike moved to San Francisco in 2004, making it his permanent home, and thereafter quickly became a successful entrepreneur, founding and running an international tax consulting firm for ten years until it was acquired in 2014; and

WHEREAS, Mike was deeply affected by his brother Timothy's untimely death in 1992, and he thereafter became involved in charitable causes benefiting children with cancer to honor his brother's memory; and
