#### **Conditions for Type 21 (Off-Sale General)**

- 1. Sales of alcoholic beverages shall be permitted between the hours of 9:00 a.m. and 10:00 p.m. daily.
- 2. Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257, dated \_\_\_\_\_\_.
- 3. No person under the age of 21 shall sell or deliver alcoholic beverages.
- 4. The sale of distilled spirits in sizes smaller than 200 ml is strictly prohibited.
- 5. The sale, service and consumption of powder alcohol or like non-liquid alcoholic beverage based product is prohibited.
- 6. No wine shall be sold with an alcoholic content of greater than 15% by volume except for "Dinner Wines" which have been aged two years or more and maintained in corked bottles.
- 7. Wine shall not be sold in bottles or containers smaller than 375 ml.
