[Affirming Final Environmental Impact Report Certification - 75 Howard Street Project]

Motion affirming the Planning Commission's certification of the Final Environmental Impact Report prepared for the project located at 75 Howard Street.

WHEREAS, The Planning Department published a draft Environmental Impact Report ("EIR") for the project located at 75 Howard Street on July 31, 2013; and

WHEREAS, The Planning Commission certified the Final EIR on September 3, 2015; and

WHEREAS, The project consists of an approximately 20-story over basement, 220foot-tall, 333,864-gross square foot high-rise tower containing up to 133 residential units and approximately 5,824 gross square feet of retail use with 102 off-street parking spaces in a two-level underground garage accessed from Howard Street; and

WHEREAS, By letter dated October 5, 2015, David Osgood filed an appeal of the certification of the Final EIR on behalf of Rincon Point Neighbors Association; and

WHEREAS, On November 17, 2015, this Board held a duly noticed public hearing to consider the appeal of the certification of the Final EIR filed by Appellant, and following the public hearing affirmed the certification of the Final EIR; and

WHEREAS, In reviewing the appeal of the Final EIR, this Board reviewed and considered the final EIR, the appeal letter, the responses that the Planning Department prepared, the other written records before the Board of Supervisors and all of the public testimony made in support of and opposed to the appeal of the certification of the Final EIR; and

WHEREAS, Following the conclusion of the public hearing, the Board of Supervisors affirmed the certification of the Final EIR for the project located at 75 Howard Street, based on
