[Board of Supervisors Regular Meeting Schedule - 2016]


#### Abstract

Motion establishing the 2016 Board of Supervisors Regular Meeting Schedule pursuant to Board of Supervisors Rules of Order, Sections 4.2, and 4.2.1, by cancelling the Board meetings of January 5, January 19, February 16, May 31, July 5, October 11, and November 8 and 22, 2016; and all Board and Committee meetings during the spring, summer, and winter breaks from March 28 through April 1, August 3 through September 5, and December 14 through December 31, 2016; and further suspending portions of Board Rule 4.2. to effectuate certain dates within the regular meeting schedule to augment the flow of business.


WHEREAS, The Board of Supervisors Rules of Order, Section 4.2, states the Board shall hold a regular meeting in the Legislative Chamber in City Hall each Tuesday at 2:00 p.m., unless it is a holiday, in which case the meeting shall be cancelled; and

WHEREAS, The Rules of Order, Section 4.2.1, also states that during holiday periods, the application of specific days of the week described in the rules shall be revised by the Clerk of the Board as necessary for the efficient conduct of the legislative process; and

WHEREAS, The Rules of Order, Section 4.2, also states the Board shall not meet during the week after Thanksgiving, nor between December 24 and December 31; and

WHEREAS, Similar to other sitting legislative bodies in the United States, the Board has established recess periods during the spring, summer and winter which Members of the Board may plan to be away, without missing any Board or Committee meetings or other important public business, and without causing difficulties in achieving a quorum; and

WHEREAS, The Board is constrained by certain administrative, electoral and legislative deadlines and may call a special meeting pursuant to Board Rule 4.3 at any time to conduct the City's business; now, therefore, be it

MOVED, Pursuant to Board Rules 4.2, and 4.2.1 the following Board meetings, are cancelled: January 5 (New Year’s Day); January 19 (Martin Luther King Jr. Day); February 16 (President's Day); May 31 (Memorial Day); July 5 (4 $4^{\text {th }}$ of July); October 11 (Columbus Day); and November 8 (Veteran's Day); and, be it

FURTHER MOVED, That pursuant to the established tradition of spring, summer, and winter recess periods, the Board and Committee meetings scheduled from March 28 through April 1, and August 3 through September 5, and December 14 through December 31, 2016, are cancelled; and, be it

FURTHER MOVED, To suspend the portion of Board Rule 4.2, which requires the Board to cancel a Tuesday Board meeting after a Monday Holiday as it pertains solely to September 5, to allow the Board to meet on Tuesday, September 6, 2016; and

FURTHER MOVED, To suspend the portion of Board Rule 4.2, which requires the Board to meet after Thanksgiving, and cancelling the meeting of November 22 to observe the Thanksgiving holiday during the week of Thanksgiving; and, be it

FURTHER MOVED, That pursuant to the Municipal Elections Code, Sections 300 (b) and 370, the Clerk of the Board is directed to include an August 2 Board Meeting to enable the Board to submit or withdraw an Ordinance or Declaration of Policy to the Director of the Department of Elections for the 2016 November Election; and, be it

FURTHER MOVED, Pursuant to Board Rule 4.3 the Board may schedule Special Meetings when necessary to conduct the City's business.
