[Budget and Legislative Analyst Review of Super Bowl 50 Revenue and Expenditures]

WHEREAS, On August 9, 2012, the San Francisco Bay Area Super Bowl 50 Host Committee submitted a bid to compete to host Super Bowl 50; and

WHEREAS, On May 21, 2013, the National Football League announced that Super Bowl 50 would take place in Santa Clara, California on February 7, 2016; and

WHEREAS, San Francisco will host a number of Super Bowl-related events including the "Super Bowl City", which will take place at Justin Herman Plaza between January 30 and February 7, 2016; and

WHEREAS, The City has undertaken extensive preparations for both the public and private Super Bowl events; and

WHEREAS, A number of City departments are anticipated to be involved in work related to the Super Bowl, including the Department of Emergency Management, the Department of Public Works, the Office of Economic and Workforce Development, the Port of San Francisco, the San Francisco Municipal Transportation Agency, the San Francisco Fire Department, and the San Francisco Police Department; and

WHEREAS, On December 7, 2015, the Board of Supervisors Land Use and Transportation Committee held a hearing on the anticipated impacts to the City from Super Bowl-related events; and

WHEREAS, Heretofore the planning, negotiation, and mobilization of resources in preparation for the Super Bowl-related events have been performed entirely by City

departments without official Board of Supervisors oversight or exercise of authority despite the expenditure of what are expected to be significant resources; now, therefore, be it

MOVED, That the Budget and Legislative Analyst is hereby directed to conduct a review of the City's revenues, expenditures, staffing plans, and service disruptions associated with hosting events related to Super Bowl 50.
