Motion appointing Duncan Talento Ley, Thea Selby, and Jennifer Garcia (residency requirement waived), terms ending August 31, 2016, to the Cannabis State Legalization Task Force.

MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated persons to serve as members of the Cannabis State Legalization Task Force, pursuant to the provisions of Administrative Code, Article II, Sections 5.2-1 through 5.2-7, for the terms specified:

Duncan Talento Ley, seat 13, new appointment, must be an owner of a small business in San Francisco, for a one-year term ending August 31, 2016.

Thea Selby, seat 14, new appointment, must be an individual with experience working for, or on behalf of, the interests of businesses in San Francisco, for a one-year term ending August 31, 2016.

Jennifer Garcia (residency requirement waived), seat 20, new appointment, must be a representative of a labor union that represents employees working in the cannabis industry, for a one-year term ending August 31, 2016.

FURTHER MOVED, That the Board of Supervisors makes the following findings:

1. The membership of the Cannabis State Legalization Task Force has a goal to be representative of the diversity of the City and County of San Francisco.

2. Applicant Jennifer Garcia, who is not a resident of San Francisco, is a person with experience that uniquely qualifies her to serve on the Cannabis State Legalization Task Force.

The Cannabis State Legalization Task Force has attempted to fill the position, for which Jennifer Garcia was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Jennifer Garcia is qualified to serve on the Cannabis State Legalization Task Force.
- 4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco, and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Cannabis State Legalization Task Force at this time; and, be it FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Jennifer Garcia, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Charter, Section 4.101(a)(2), that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.







# Addendum

California State Legalization Task Force Application - Stewart Rhoads

The new San Francisco CSL Task Force will need to accomplish 3 main objectives in fulfilling its mandate:

- I. Protect public safety
  - A. Develop regulations for cannabis production, testing, and sales, edibles especially, in advance of ballot initiative passage.
  - B. Address issues related to product quality control, land use, and building safety.
  - C. Develop protocols preventing children from obtaining cannabis.
- II. Facilitate capture of tax revenues
  - A. Differentiate between adult use and legitimate therapeutic use of medical cannabis by seriously ill individuals for certain conditions only, including HIV/AIDS and cancer.
  - B. Ensure residents and tourists have access to venues for acquisition and consumption.
  - C. Direct revenues to maximize public benefit, such as was done in Colorado by funding the education system.
- III. Support the San Francisco entertainment industry
  - A. Determine whether and how cannabis can be sold and/or consumed in nightclubs, restaurants, and cafes.
  - B. Limit undue impact on neighborhoods and actively promote San Francisco's reputation as a world class destination.

- Born in San Francisco (1979), resident and registered voter since 2001.

My name is Michael Buff. I am the owner of Medorganics LLC, a cannabis cultivation consulting company. As a result of our neighborhood negotiations with SPARC, I am aware of the difference of magnitude between what other merchants make and what cannabis clubs make. I am also aware that there are issues that arise with cannabis clubs that do not with other merchants mostly from the frequency and quantity of customers they have, odor, etc. I would love to help make a difference in how we establish our state cannabis laws to make them fair to the cannabis clubs and to make sure that we regulate appropriately so that residents who live nearby do not suffer.

I've personally known Sabrina for over fifteen years, since she was a college student who passionately fought for social justice reform of all kinds, including ending the arrests of otherwise law-abiding citizens who choose to consume marijuana.

I have personally spent my entire career working in marijuana law reform and the emerging cannabis industry, so I take proposals like Supervisor Weiner's very seriously. In my career I have served as the associate director of the National Organization for the Reform of Marijuana Laws and executive director of Students for Sensible Drug Policy. I currently serve on the national boards of directors of SSDP, Marijuana Majority, and the National Cannabis Industry Association. In my current job, I am managing partner of 4Front Advisors, a national cannabis business consulting firm with a reputation for helping our clients establish some of the most professional and compliant dispensaries in the country. In my previous role, I was involved in helping develop successful dispensary models in the greater Bay Area, including SPARC in San Francisco, and Harborside and Elemental Wellness in San Jose.

Given my background, it is of the utmost importance to me that commissions such as this are populated by people who will take their roles seriously, and dedicate themselves to crafting policies that will positively impact their communities and mitigate any potential harms that come with major policy changes such as legalizing cannabis. In my experience, the city of San Francisco could do no better than Sabrina Matlin serving on such a committee. As a parent, home owner, long-term resident who has worked with and assists my diversified neighbors regarding problems, which included drug selling and gang activities, at my corner and in my neighborhood, I would bring an experienced point of view.

I am a former union organizer, representative and lawyer for Local 2 which at the time was Hotel Employees & Restauant Employees Union (now UNITE HERE). I also worked as an attorney for the Retail Clerks Union, Local 1100, which is now UFCW, and it represents the cannabis workers. I recently worked as Staff Attorney for the California Labor Comissioner (5 years) which represents low-wage workers, primarily in the underground economy. I have extensive knowledge of the state's labor laws. The potential legalization of marijuana will have a tremendows effect upon our economy, its workers and business owners. Further, legalization will move the regulation of cannabis into the world of administrative law where I also have a great deal of experience. I am a former prosecutor (15 years) and worked closely with Terrence Hallinan and Kamala Harris who were and may yet still be important for the smooth introduction of recreational cannabis into our city. (Note that the Pathways Report headed by Lt. Governor Newsom stated that legalization will not be an event but a "process.") Mr. Hallinan and Ms. Harris attempted to balance the compassionate use of medical marijuans with publi safety and I expect we will need to do the same with recreational marijuana.

The Cannabis State Legalization Task Force (Task Force) was established to advise the Board of Supervisors, the Mayor, and other City departments on matters relating to the potential legalization of cannabis so that the policymakers are fully prepared to address policy questions through legislation and administrative actions, following the adoption of a State law.

The Task Force consists of 22 members (seats 1 through 7 shall be non-voting members):

DEPARTMENT HEAD MEMBERS

- > Seat 1: Director of the Department of Public Health, or his/her designee
- > Seat 2: Chief of the Fire Department, or his/her designee
- > Seat 3: Chief of the Police Department, his/her designee
- > Seat 4: Director of the Department of Building Inspection, or his/her designee
- > Seat 5: Director of Planning, or his/her designee
- > Seat 6: Executive Director of the Entertainment Commission, or his/her designee

> Seat 7: Executive Director of the California Board of Equalization, or his/her designee (if the Executive Director declines and fails to appoint a designee for 60 days or longer, the Board of Supervisors may appoint a member of the public)

> Seat 8: Superintendent of the San Francisco Unified School District, or his/her designee which may include a Member of the Board of Education (if the Superintendent declines and fails to appoint a designee for 60 days or longer, the Board of Supervisors may appoint a member of the public)

> Seat 22: Must be an individual between the ages of 21 and 30 at the time of appointment.

The Public Members in seats 9 through 22 shall serve for a term of one year. The initial term for each seat shall begin on August 31, 2015. At the end of the one-year term, the Board of Supervisors may reappoint the member by written motion without soliciting applications from additional applicants.

The Department of Public Health shall provide clerical and administrative support and staffing for the Task Force. The Task Force shall hold a regular meeting not less than five times per year.
