1	[Industrial Lease Agreement - Tanforan Industrial Park, LLC - Bus Operator Training Courses - \$2,480,304 Initial Annual Base Rent]
2	
3	Resolution authorizing the San Francisco Municipal Transportation Agency (SFMTA) to
4	execute an Industrial Lease Agreement with Tanforan Industrial Park, LLC, for
5	approximately 7.3 acres of space located at 30 Tanforan Avenue, South San Francisco,
6	to be used for SFMTA bus operator training courses for a nine and one-half year term
7	estimated to be from October 1, 2016, through February 28, 2026, with an initial annual
8	base rent of \$2,480,304 and annual 2% rent increases; the lease includes a purchase
9	option, right of first refusal, and an extension option.
10	
11	WHEREAS, There has been a 10% growth in Muni service hours and an additional 2%
12	growth projected to meet the City's transit needs; and
13	WHEREAS, It is expected that future transit service needs will need to be increased to
14	support the projected growth in the City; and
15	WHEREAS, The San Francisco Municipal Transportation Agency ("SFMTA") has
16	recently hired new Muni operators to meet this service need which has been a key component
17	of delivering 99% of service and increasing on time performance; and
18	WHEREAS, Each new operator requires at least 44 days of training, which includes on-
19	and off-road experience for skill development and DMV testing; and
20	WHEREAS, Training is not limited exclusively for new hires but is an ongoing
21	requirement to ensure safety; and
22	WHEREAS, A bus operator training course requires approximately 6-8 acres of
23	improved land, and access to such parcels of land to meet such needs are very limited in San
24	Francisco and surrounding communities; and

1	WHEREAS, SFMTA does not have a dedicated training resource within its existing real
2	estate portfolio to adequately accommodate its new hire training classes which has negatively
3	impacted the ability to deliver adequate transit services and will continue to do so until a
4	dedicated resource is available as needed by SFMTA for ongoing and continual operator
5	training; and
6	WHEREAS, SFMTA has sought to conduct behind-the-wheel training through short-
7	term leasing or licensing, but in most cases, the locations sought were either not available at
8	the level of consistency required by the Training Section or the sites were not adequate in
9	size, use or improvement; and
10	WHEREAS, The property at 30 Tanforan Avenue, South San Francisco, San Mateo
11	County Assessor's Parcel Number 014-250-090 was identified and deemed the best solution
12	by MTA Transit and Training units for providing an adequate, consistent and reliable location
13	for bus operator training; and
14	WHEREAS, SFMTA desires to execute a nine and one-half year lease ("Lease") with
15	Tanforan Industrial Park, LLC ("Lessor"); and
16	WHEREAS, The lease agreement includes the following key terms and conditions:
17	(a) Term. The Term of the Lease is nine and one-half (9 $\frac{1}{2}$) years.
18	(b) Rent. Under the Lease, SFMTA will pay an initial annual base rent of \$2,480,304
19	(\$.65 per square foot), with annual rent increases of two percent.
20	(c) Purchase Option. SFMTA will have the right to exercise a Purchase Option to
21	acquire the property in years seven through nine.
22	(d) Right of First Refusal. SFMTA will have a Right of First Refusal to acquire the
23	property throughout the entire term of the Lease.
24	(e) Option to Extend. SFMTA will have an option, exercisable in SFMTA's sole
25	discretion, to extend the term of the Lease.

1	WHEREAS, On January 19, 2016, the SFMTA Board of Directors approved Resolution
2	No. 16-011 authorizing the Director of Transportation of the SFMTA to execute the Lease and
3	to forward to the Board of Supervisors for final approval; and
4	WHEREAS, A copy of the Lease, including all exhibits, is on file with the Clerk of the
5	Board of Supervisors in File No. 160091, which is hereby declared to be part of this
6	Resolution as if set forth fully herein; and
7	WHEREAS, Due to the character of the Lease, approval by the Board of Supervisors is
8	required under Charter, Section 9.118; now, therefore, be it
9	RESOLVED, That The Board of Supervisors authorizes the Director of Transportation
10	of the SFMTA to enter into any amendments or modifications to the Lease (including, without
11	limitation, the exhibits), that the Director of Transportation determines, in consultation with the
12	City Attorney, are in the best interest of the City, do not materially decrease the benefits of the
13	Lease to the City, do not materially increase the obligations or liabilities of the City, are
14	necessary or advisable to effectuate the purposes of the Lease or this Resolution, and are in
15	compliance with all applicable laws, including City's Charter; and, be it
16	FURTHER RESOLVED, That the Board of Supervisors approves the Lease between
17	the City and County of San Francisco and Tanforan Industrial Park, LLC; and, be it
18	FURTHER RESOLVED, That within 30 days of the document being fully executed by
19	all parties, the final document shall be provided to the Clerk of the Board for inclusion in the
20	official file.
