Dear Bill,

Congratulations on being nominated to be a commissioner on the Veterans Affairs Commission. They're making a great choice in you. I wish I could write you a letter of recommendation, but the SFPD specifically prohibits testimonials.

When I met you 5 years ago, I was a brand new captain at Taraval Station. I remember you telling me of your many years of service in the Air Force and Air Force Reserves. It was very evident how much you cared about the military and especially its men and women.

That caring still shows through in the things you have done for the community. Five years ago, you came to me and said that you wanted to conduct a toy drive with Taraval Police Station for the underprivileged children in San Francisco. I said, "sure", but I really didn't have to do anything. You did all the work and collected hundreds of toys that year. These toys were given out to underprivileged children in the Taraval Police District and in other parts of San Francisco. Every year since that first toy drive has gotten bigger and better. Last year was the best. You raised thousands of toys. These toys went to underprivileged children all over San Francisco; Chinatown, Tenderloin, Portola, and Mid-Market.

We even had about 20 toys left over. I intended to save them for next year, but I heard that offduty law enforcement officers were traveling to the Philippines to teach Filipino police officers investigative techniques, defensive tactics, and force options. One other thing they do is to visit schools. They go to the poorest schools and bring schools supplies to give to them. When I asked if I could give the 20 left over toys to the officers going to the Philippines, not only did you say yes, but you gave me 30 more toys. The officers recently came back, they said that we made a lot of kids happy with the toys. The officers said that the schools were very poor and so rural that they had to walk for hours carrying the supplies because there were no roads to the school. You made those children happy.

Toys you collected not only went to under privileged children in San Francisco, they went to some extremely poor children in the Philippines.

Even as the current president of the Outer Sunset Professional and Merchants Association your leadership has shone through. When you first became president last year, there were only about 15 merchants in the association. Now there are almost 100.

Your leadership and community service has been recognized several times. You were honored by the San Francisco Police Commission for your work. Last year, you were honored by the San Francisco Police Department Asian Pacific Islander Community Police Advisory Board for your commitment to the community. You even have been recognized by the San Francisco Board of Supervisors.

His presentation was part of the "Food for Your Brain" lecture series which is designed to present veterans in all stages of recovery from drug abuse and mental disorders with information and tools that will serve them in life and help them to be more informed and better their lives. Topics covered include medical information on drug abuse and infectious disease, legal and financial topics, alternative medicine, stress reduction and spiritual/inspirational topics.





Re: Appointment to the Veterans Affairs Commission of San Francisco

Thank you for considering me for the appointment to the Veterans Affairs Commission. I deeply apologize for being unable to present in person today. For today, I play a critical role at the San Francisco VA hospital with a crucial inspection to keep the hospital accredited as a high reliability facility. In my position as Acting Associate Chief of Quality Management, I meet with the Director of the VA here in San Francisco daily and keep her advised of the facility.

Keeping the medical center and its clinics accredited is important to San Francisco because of our affiliation with the University of California at San Francisco (UCSF). We are responsible for supporting the education of future medical doctors that serve UCSF and SF General Hospital. We also are the largest research center of any VA in the nation providing new innovative treatments in health care.

One of my interests is to work with the city to see about setting up subsidized housing for the housekeeping staff of the VA employees. Those employees are all Veterans per national VA Policy. Many have taken the jobs as a way to become productive in life again after difficulties. They are the lowest paid employees within the VA and it would take an act of Congress to increase their wages. Many of them live two hours away and commute into SF. They often choose to work overtime to earn extra money and end up sleeping in their cars. The most notable importance of these Veterans is the role that they play in the access of care for other Veterans. When they are not able to clean a room, due to not enough staff, it delays admissions of very ill Veterans. Those many hours of delay back up the emergency room, stop the transfer process from outside hospitals, and delay elective procedures for Veterans. It also puts the hospitalized Veterans at risk of acquiring hospital infections from not having enough housekeeping staff.

I realize that this is a grand dream; however, it could benefit so many Veterans if this ever becomes a reality.

At the age of 18 during the Vietnam War, she was deeply affected by the boys of her neighborhood either not returning or coming home damaged from the war. She then raised her right hand to join the Army entering a nursing academy to support the soldiers. She continues with her career in nursing as an administrator. Her earlier career was as an intensive and cardiac care nurse and then she moved onto being an operating room manager. She volunteers in support of veterans recovering from PTSD and supported the Veteran's Book project for helping veteran's tell their stories of war and service. Since 2013, she worked on several projects in a national fellowship of healthcare simulation at San Francisco Veterans Affairs Medical Center. Those projects included: Developing a new type of hybrid-operating room to alleviate to tremor for Veterans suffering with Parkinsons; Disaster evacuation of complex patients; and Immediate care before the code team arrives. Mary-Ann presented information on moral injury and her plans for research using simulation at Phoenix Arizona during their research agenda "VA research making a difference." Recently she introduced the journalist, Suzanne Gordon, to a lead researcher at San Francisco VA to publicize the new successful treatment for Veterans suffering with Moral Injury. Mary-Ann received her bachelor's degree from the University of Maryland through an Army Nursing Academy call the Walter Reed Army Institute of Nurse and her master's from the University of California, San Francisco. The Veterans Affairs Commission consists of a total of seventeen (17) members, twelve (12) of whom are appointed by the Board of Supervisors and five (5) of whom are appointed by the Mayor as follows:

• At least three (3) must be women veterans (at least two (2) members shall be appointed by the Board);

• Two (2) members who served in the Armed Forces of the United States and who have a physical disability arising from that service (the Mayor and Board of Supervisors shall each appoint at least one (1) member), in accordance with the definitions applied in such cases by the Veterans' Administration; and

• All members shall reside in the City and County of San Francisco. The Board of Supervisors may only waive this requirement by Ordinance.

The term of each member of the Commission shall be four (4) years; provided, however, that the members first appointed shall, by lot, classify their terms so that three (3) members shall serve a one-year term, four (4) members shall serve a two-year term, four (4) members shall serve a three-year term and four (4) members shall serve a four-year term. On the expiration of these and all successive terms, their successors shall be appointed for a four-year term in a manner similar to that described for the initial members. In the event a vacancy occurs during the term of office of any member, a successor shall be appointed for the unexpired portion of the term of the office vacated in a manner similar to that described for the initial rembers.
