The Eastern Neighborhoods Citizens Advisory Committee (CAC) was established to be the advisory body charged with providing input to City agencies and decision makers on all activities related to the implementation of the Eastern Neighborhoods Area Plans: 1) East SoMa, 2) Western SoMa, 3) Mission, 4) Showplace Square/Potrero Hill, and 5) Central Waterfront (Plan Areas). The CAC shall provide input on the prioritization of public benefits, updating the public benefits program, relaying information to community members in each of the four neighborhoods regarding the status of development proposals in the Eastern Neighborhoods, and providing input to Plan Area monitoring efforts.

The CAC shall consist of nineteen (19) members that represent the diversity of the Eastern Neighborhoods (key stakeholders), including resident renters, resident homeowners, low-income residents, local merchants, established neighborhoods groups within the Plan Area, and other groups identified through refinement of the CAC process:

- > Four (4) members nominated by the District 10 Supervisor
- > Two (2) members nominated by the District 9 Supervisor
- > One (1) member nominated by the District 8 Supervisor

Business and/or professional experience:

As a staffer working on housing issues in the Mission, I am heavily involved in the systems which manifest from the Eastern Neighborhood Area Plans. An example of this is my participation in community-wide, and city-wide coalitions which work on advocating for, and/or providing input to land use policies.

A large part of my current position acknowledges the importance of bringing vital information to the community so that they are aware of what is occurring in terms of projects, and policies in their neighborhood. This is in line with one of the core duties of the committee, which is to relay information to community members.

Civic Activities:

Recently, I volunteered some of my time outside of work to help garner support for various propositions put towards the voters of San Francisco. For example, during the last election cycle, the Mayor put forth a housing bond to be voted on (Proposition A), and not only did I personally speak with people about the importance of passing the measure, I spoke with businesses in two different districts (2, and 9) to display a support sign on their store fronts.

Furthermore, part of my professional responsibilities is to educate, and train community members on how to provide their own input, usually via public comment during official city hearings and meetings, on various policies or projects effecting them.
