10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Kuiana Taylor v. City and County of
12 San Francisco, United States District Court Case No. 14-cv-03555 CRB, by the payment of
13 \$49,999. The lawsuit involves an employment dispute.


14 Section 2. The above-named action was filed in United States District Court for the


