WHEREAS, On February 2, 2016, the Board of Supervisors approved the Castro/Upper Market CBD's annual reports for FY2013-2014 in Resolution No. 40-16; and

WHEREAS, The Castro/Upper Market CBD has submitted for the Board's receipt and approval the Castro/Upper Market annual reports for FY2014-2015 as required by Section 36650 of the Act and Section 3.4 of the Management Contract; and

WHEREAS, The Annual Report is on file with the Clerk of the Board of Supervisors in File No. 160161 and are incorporated herein by reference as though fully set forth; and

WHEREAS, Supporting documents, including, but not limited to, a transmittal letter and memorandum report from the City's Office of Economic and Workforce Development, dated February 16, 2016, and documentation from the Castro/Upper Market CBD for the Annual Report is on file with the Clerk of the Board of Supervisors in File No. 160161; now, therefore, be it
