3 **Resolution authorizing the Children and Families Commission to retroactively accept**  
4 **and expend a grant in the amount of \$1,269,400 from the United States Department of**  
5 **Education through the California Department of Education to support an Early Learning**  
6 **Quality Improvement System for the period of July 1, 2012, through December 31, 2015.**

8 WHEREAS, The California Department of Education ("CDE") has awarded a Race to  
9 the Top - Early Learning Challenge grant to the San Francisco Children and Families  
10 Commission ("First 5 San Francisco") in the amount of \$1,269,400 from July 1, 2012 through  
11 December 31, 2015 to support an Early Learning Quality Improvement System to improve  
12 early learning and development programs for young children; and

13 WHEREAS, On September 6, 2012, the Executive Director of First 5 San Francisco  
14 entered into an agreement with CDE to accept the grant; and

15 WHEREAS, Under the grant agreement CDE requires First 5 San Francisco to apply  
16 the awarded funds for activities to support the local Quality Rating and Improvement System  
17 for early care and education programs proposed in the action plan submitted to CDE; and

18 WHEREAS, First 5 San Francisco will prepare and submit reports required by the CDE;  
19 and

20 WHEREAS, First 5 San Francisco proposes to maximize use of available grant funds  
21 on program expenditures by not including indirect costs in the grant budget; now, therefore,  
22 be it

23 **RESOLVED**, That the Board of Supervisors hereby waives inclusion of indirect costs in  
24 the grant budget; and be it


1 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the




