[Settlement of Lawsuit - Fernando Guanill - \$150,000]

Ordinance authorizing settlement of the lawsuit filed by Fernando Guanill against the City and County of San Francisco for \$150,000; the lawsuit was filed on October 14, 2015, in the United States District Court for the Northern District of California, Case No. 15-cv-04745 LB; entitled <u>Fernando Guanill v. Michael Robert Lewelling, et al.</u>; the lawsuit involves alleged civil rights violations.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Fernando Guanill v. Michael Robert</u> <u>Lewelling, et al.</u>, United States District Court for the Northern District of California, Case No. 15-cv-04745 LB by the payment of \$150,000. The lawsuit involves alleged civil rights violations.
