Ordinance authorizing settlement of the lawsuit filed by Lisa Owen against the City and County of San Francisco for \$2,250,000; the lawsuit was filed on July 8, 2014, in San Francisco Superior Court, Case No. CGC-14-540434; entitled <u>Lisa Owen v. Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Lisa Owen v. City and County of San Francisco</u>, et al., San Francisco Superior Court, Case No. CGC-14-540434 by the payment of \$2,250,000. The lawsuit involves an alleged dangerous condition of public property causing personal injury.
