Dear Honorable Committee Members,

I strongly urge the committee to consider knocking down old Potrero Police Station and Hospital at 2300 3rd St. in favor of building more housing.

Housing is what this city needs, and is what we are desperate for. Not a community center.

As to whether we build market rate or BMR housing is of less concern to me. I would be happy with the standard 30% affordable housing ratio or 100% affordable. SF Gate recently published a shocking statistic that over 70% of the homeless in San Francisco \*used to have homes here\*.

While the NIMBY factions in every neighborhood are well organized and vocal, including here in Dogpatch, please keep in mind that they are the minority. By every publicly measurable opinion, the vast majority of San Franciscans think that housing is our biggest issue.

Using this land for a community center is not in the public interest -- it is in the interest of established NIMBYs who want their property values to go up and extract rents from the under and moderately privileged.

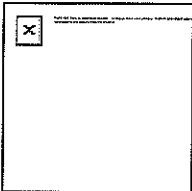
