Dear Ms. Bruss,

I am a voter and homeowner at 850 Minnesota Street in Dogpatch, writing to register my opinion that the parcel at 2300 3rd Street (the historic old Potrero Police Station) should NOT BE DEVELOPED FOR ANY FORM OF HOUSING.

Dogpatch is in the midst of an enormous housing boom, with a half-dozen projects underway and more planned (including directly across 20th St. from the parcel in question). We cannot accommodate any more housing of any type.

Our amenities are hugely overtaxed - parking has gone from plentiful to non-existent in a few years, and the Muni T-Third line is incredibly overused. My pregnant wife routinely has to stand, squeezed in, on her morning commute. 

Subject: Removing the Potrero Police Station and Hospital from the City's Surplus Property List

Dear Honorable Land Use Committee Members, Supervisor Malia Cohen, Supervisor Aaron Peskin and Supervisor Scott Weiner:



We, as a community, are requesting that the site of the Old Potrero Police Station and Hospital should be removed from the Surplus Property list for conversion to affordable housing for the following reasons:

# 1. Dogpatch has and is making enormous contributions to the affordable housing crisis that we all agree needs to be addressed:

Unlike the rest of San Francisco for which Section 415 of the San Francisco Planning Code requires residential developments **with 10 or more units** to pay an Affordable Housing Fee, the the stricter Easter Neighborhoods code requires that market-rate developments **larger than five units** provide **15-20 percent** of their units at below market rate, pay an affordable housing fee or provide 20% of their units off-site as affordable to low- to moderate-income households.

So if we do the math, *starting in 2010 through 2030, 5000 housing units have been built, are under construction, entitled, or in planning, in Dogpatch ALONE.* 

Of the 2500 units built or scheduled to be completed by 2020, 100% of these 24 projects are over 5 units, therefore contributing between 250 and 500 units, or their equivalent, in affordable housing land or funds.

We are in support of adding as much affordable housing as we can build, and in fact the Dogpatch Neighborhood Association encourages developers to build their due affordable housing on site to avoid economic segregation, but as the numbers show, we are already fulfilling our neighborhood duty to aid in the housing crisis, making the inclusion of the Old Potrero Police Station and Hospital on the surplus property list for affordable housing inappropriate; instead, we believe it is high time to prioritize the adding of crucial public services to keep our community healthy.

- 3. The property is home to two significantly contributing historic buildings. This means the buildings both contribute to the Dogpatch historic district AND have the higher designation as individual properties of significance in the Historic Dogpatch Neighborhood Survey, therefore they are significant in their own right for designation on The National Register of Historic Places. Only so many buildings that are contributing can be demolished that carry this status before the City would lose this historic district status altogether, so preserving these properties is important from that standpoint as well.
- 4. We have identified potential funding sources for for the significant repair and adaptive reuse of these historic resources to convert them into a vibrant, neighborhood serving community hub, and to also preserve the legacy to the past and connection between Dogpatch and the historic core of Pier 70, for which these buildings serve as a fitting and important gateway.

With such rapid, high intensity growth happening in Dogpatch, in which the population will triple by 2020 and quintuple by 2030, we feel the old Potrero police station and hospital would better serve our community, as well as the entire Central Waterfront from Mission Bay to India Basin and Potrero Hill as a neighborhood center—the first of its kind since Dogpatch's inception over 150 years ago.

My name is Jean Chui and I am a resident at 868 Minnesota St in Dogpatch. As a member of the neighborhood, I respectfully request that the Potrero Police Station and Hospital at 3rd & 20th St come off the surplus property list to be used for community space instead of affordable housing.

While I appreciate the need for affordable housing in San Francisco and am fully in support of it, there are a myriad of reasons this property is not an appropriate choice for an affordable housing project. The fact that (1) the lot size is too small and (2) the historic buildings cannot be torn down, makes converting this property into affordable housing prohibitively expensive. The city should be using its limited funds in a way that is economically sensible.

Further, the Dogpatch population in its current size is already under-served with respect to critical elements of a complete neighborhood (ie. libraries, rec/community centers, etc.). Unless the city allows community space to be built, this problem will only be exacerbated as new developments become complete in the immediate future.
