2 Taylor Street]

3 Resolution approving the addition of the commemorative street name "Gene
4 Compton's Cafeteria Way" to the 100 Block of Taylor Street in recognition of the
5 Fiftieth Anniversary of the turning point for the civil rights movement for Gay, Lesbian,
6 Bisexual, Transgender, Queer, Questioning, and Intersex people, and in specific the
7 contributions of Transgender Women.

9 WHEREAS, Gene Compton's Cafeteria, located on the 100 block of Taylor Street, at
10 the intersection of Turk, was a hub for transgender and gay people and served as a meeting
11 place for transgender women and gay hustlers in the Tenderloin; and

12 WHEREAS, In August of 1966, transgender women and gay people had been
13 repeatedly mistreated by law enforcement and made an executive decision to stand up for
14 their human rights, regardless of regular police presence at Compton's Cafeteria; and

15 WHEREAS, The Compton's Cafeteria riots mark the turning point for gay, lesbian,
16 bisexual, and transgender liberation nationwide; and

17 WHEREAS, The Compton's Cafeteria riot symbolize the contributions of transgender
18 women and the gay community to human rights in the 1960's and reminds us of a time where
19 ignorance meant transgender and gay people were beaten, raped, killed, harassed, jailed,
20 and disowned by society, and that we must still continue to fight ignorance today; and

21 WHEREAS, In the present day, there is insufficient institutional infrastructure or cultural
22 tradition for the annual commemoration of these outstanding contributions by transgender
23 women to the gay civil rights movement currently exists; and

1 WHEREAS, It is the responsibility of those elected to office to memorialize transgender
2 people and gay people who endured violence and discrimination in the name of solidifying the
3 constitutional rights of the community; and

4 WHEREAS, The approaching fiftieth anniversary of the Gene Compton's Cafeteria
5 Riots is worthy of community celebration and commemoration by community, law
6 enforcement, politicians, and civilians alike; now, therefore, be it

7 RESOLVED, There shall be an honorary naming of "Gene Compton's Cafeteria Way"
8 in recognition of the valued contributions to Transgender women to social justice movements,
9 to the City and County of San Francisco and the community of the Tenderloin; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors requests the Municipal
11 Transportation Agency ("SFMTA") to erect street signs indicating both the honorary and the
12 existing names of the street, either on a single sign or on separate signs, with the honorary
13 name "Gene Compton's Cafeteria Way" in smaller letters, and the existing name "Taylor
14 Street" in larger letters above or beneath the honorary name; and, be it

15 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
16 Francisco urges the SFMTA to expedite the installation of the approved new sign in time for
17 the Trans March on June 24, 2016; and, be it

18 FURTHER RESOLVED, That the street renaming is commemorative in nature and not
19 subject to procedural hearings or noticing pursuant to Streets and Highway Code, Section
20 970.5, or San Francisco Transportation Code, Section 2.2; and, be it

21 FURTHER RESOLVED, That the Department of Public Works is directed to add the
22 honorary street name to its official list of Commemorative Street Names in accordance with
23 Public Works Code, Section 789 et seq.
