

1 [Approval of a 150-Day Extension for Planning Commission Review of Inclusionary Affordable  
2 Housing Program (File No. 150911)]

3 **Resolution extending by 150 days the prescribed time within which the Planning**  
4 **Commission may render its decision on an Ordinance (File No. 150911) amending the**  
5 **Planning Code to provide revised geographic, timing, pricing, and other requirements**  
6 **for the off-site alternative to the Inclusionary Housing Fee; create a new option for off-**  
7 **site projects that qualify as Nonprofit Provider Partner Projects; create a new**  
8 **alternative for project sponsors of smaller market-rate projects to direct the Affordable**  
9 **Housing Fee to small sites projects; create an option for project sponsors of on- and**  
10 **off-site housing to provide higher amounts of affordable housing at higher levels of**  
11 **affordability termed “dialing up;” revise certain definitions and operating procedures**  
12 **related to the Inclusionary Housing Program and make conforming changes; and**  
13 **affirming the Planning Department’s determination under the California Environmental**  
14 **Quality Act, and making findings of consistency with the General Plan, and the eight**  
15 **priority policies of the Planning Code, Section 101.1.**

17 WHEREAS, On September 15, 2015, Mayor Edwin M. Lee and Supervisors Mark  
18 Farrell and Katy Tang introduced legislation amending the Planning Code to provide revised  
19 geographic, timing, pricing and other requirements for the off-site alternative to the  
20 Inclusionary Housing Fee; create a new option for off-site projects that qualify as Nonprofit  
21 Provider Partner Projects; create a new alternative for project sponsors of smaller market-rate  
22 projects to direct the Affordable Housing Fee to small sites projects; create an option for  
23 project sponsors of on- and off-site housing to provide higher amounts of affordable housing  
24 at higher levels of affordability termed “dialing up”; revise certain definitions and operating  
25 procedures related to the Inclusionary Housing Program and make conforming changes;

1 affirming the Planning Department's determination under the California Environmental Quality  
2 Act; and making Planning Code, Section 302 findings, and making findings of consistency  
3 with the General Plan, and the eight priority policies of the Planning Code, Section 101.1; and

4 WHEREAS, A copy of said legislation is on file with the Clerk of the Board of  
5 Supervisors in File No. 150911 and is incorporated herein by reference; and

6 WHEREAS, On or about September 22, 2015, the Clerk of the Board of Supervisors  
7 referred the proposed ordinance to the Planning Commission, which currently is reviewing the  
8 proposed ordinance; and

9 WHEREAS, The Planning Commission shall, in accordance with Planning Code,  
10 Section 306.4(d), render a decision on the proposed Ordinance within 90 days from the date  
11 of referral of the proposed amendment or modification by the Board to the Commission; and

12 WHEREAS, Failure of the Commission to act within 90 days shall be deemed to  
13 constitute disapproval; and

14 WHEREAS, The Board, in accordance with Planning Code, Section 306.4(d) may, by  
15 Resolution, extend the prescribed time within which the Planning Commission is to render its  
16 decision on proposed amendments to the Planning Code that the Board of Supervisors  
17 initiates; and

18 WHEREAS, The Board of Supervisors extended the time in which the Planning  
19 Commission may review the proposed ordinance by 90 days to May 4, 2016, per Board File  
20 160077 (Resolution No. 044-16); and

21 WHEREAS, Mayor Lee and Supervisors Farrell and Tang have requested additional  
22 time for the Planning Commission to review the proposed Ordinance; and

1           WHEREAS, The Board deems it appropriate in this instance to grant to the Planning  
2 Commission additional time to review the proposed Ordinance and render its decision; now,  
3 therefore, be it

4           RESOLVED, That by this Resolution, the Board hereby extends the prescribed time  
5 within which the Planning Commission may render its decision on the proposed Ordinance for  
6 approximately 150 additional days, until October 1, 2016.




