To The San Francisco Board of Supervisors,

Our names are Neil Robson and Glenn Moala and 4 years ago we decided to adopt. While in the foster adopt licensing process it became evident that Glenn's nephews; Isaiah and Meafua would soon be seeking new homes as their parents were struggling in many aspects of their lives.

That is when Patricia (Patty) Siehl came into the picture, as she was their court appointed attorney. This process can be overwhelming when prospective parents are thrown into this daunting process of adopting. We had numerous phone conversations, more than we can remember, and met with Patty where she would go over paperwork and inform us how the parents were doing, making sure the adoption was on track.

These boys were living in the Double Rock area of San Francisco, and were subjected to many bad and hurtful actions in their early years. Things they saw included the shooting death of a 16yo neighbor and the arrest of their mother following her slapping one of the children in a fit of anger; things we could not imagine seeing in our youth. As a result Meafua has had some issues in school but is responding well to therapy, which was another area that Patty helped facilitate.

There were many times when we had questions and concerns when we would pick up the phone and Patty would be there. During and especially after the adoption there were many times that we could not get in touch with either social workers or case managers with regards to urgent issues and we knew

that one phone call to Patty would get these issues taken care of quickly.

It is very troubling to us to see that Patty and other attorneys like her have not had a pay raise in over 10 years, and even more troubling that they are not offered any benefits. These attorneys do what they do because they are affected by what these children go through and fight for their best interests; often working in somewhat dangerous environments.

We are sorry that we could not make it to this hearing today as we both work fulltime, with benefits, in order to raise these children in a warm and loving home. We could not have gone through this adoption without the guidance of Patty Siehl.
