RESOLUTION 2015-59 APPROVING EXTENSION AGREEMENT BETWEEN THE CITY AND COUNTY OF SAN FRANCISCO AND THE MODESTO IRRIGATION DISTRICT

WHEREAS, the Raker Act of 1913 provides for the sale of excess electrical energy from the Hetch Hetchy facilities to the Modesto Irrigation District ("MID") by the City and County of San Francisco ("CCSF"); and

WHEREAS, MID and CCSF operate interconnected facilities at MID's Standiford substation; and

WHEREAS, pursuant to Board Resolution 2007-181, MID and CCSF entered into the Long Term Energy Sales Agreement Between the City and County of San Francisco and the Modesto Irrigation District ("LTESA") for the sale of power and the operation of interconnected facilities which became effective January 1, 2008 with a term through June 30, 2015; and

WHEREAS, MID and CCSF entered into negotiations in December 2014 for a successor agreement to the 2008 LTESA and require additional time to negotiate; and

WHEREAS, MID and CCSF wish to extend the term of the 2008 LTESA through June 30, 2016;

BE IT RESOLVED, That the Board of Directors of the MID approve and authorize the General Manager to execute the Extension Agreement of the LTESA between MID and CCSF, subject to legal approval.
