6 **and County of San Francisco, et al.; the lawsuit involves personal injury due to uneven**
7 **road surface.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Martha Abbene v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-543761 by the
13 payment of \$81,000. The lawsuit involves personal injury due to uneven road surface.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 January 21, 2015, and the following parties were named in the lawsuit: Plaintiff Martha
16 Abbene; Defendants City and County of San Francisco and Pacific Gas and Electric






