3 **Ordinance amending the Fire Code to increase the Fire Department Overtime Fee from**  
4 **\$133 to \$134 per hour.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The Fire Code is hereby amended by revising Chapter 1, Section 113.10, to  
14 read as follows:

15 **113.10. [For SF] Overtime Fee.**

16 If a person requests an inspection or other service that requires the assigned Fire  
17 Department employee to work outside of the employee's normal working schedule, the  
18 Department ~~shall~~ *will* charge an overtime fee of ~~\$133.00~~ \$134 per hour. The person requesting  
19 the services shall pay the fee before the inspection or other service is performed. The  
20 minimum compensation is four hours.

21 Section 2. Effective and Operative Dates. This ordinance shall become effective 30  
22 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor  
23 returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it,  
24 or the Board of Supervisors overrides the Mayor's veto of the ordinance. This ordinance shall  
25 become operative on its effective date or on July 1, 2016, whichever is later.

1 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
2 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
3 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
4 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
5 additions, and Board amendment deletions in accordance with the "Note" that appears under  
6 the official title of the ordinance.

Amendments to Current Law

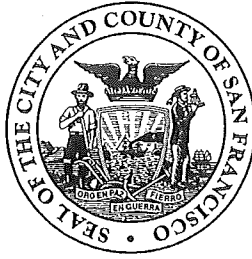
The proposed legislation would increase the fee for overtime.

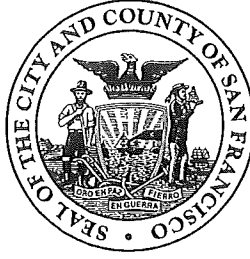


