RESOLVED, That San Francisco Print Media Co., commonly known as The Examiner, and the San Francisco Chronicle, newspapers of general circulation published in the City and County of San Francisco for the dissemination of local or telegraphic news and intelligence of a general character, having a bona fide circulation of at least 50,000 copies per calendar week are hereby designated as official newspapers of the City and County of San Francisco for the publication of all official advertising of the City and County for FY2016-2017; and, be it

FURTHER RESOLVED, That the Office of Contract Administration is hereby authorized to enter into a contract with San Francisco Print Media Co., commonly known as The Examiner, for the period of July 1, 2016, through December 31, 2016, and The San Francisco Chronicle for the period of January 1, 2017, through June 30, 2017, and said contract(s) must be in accordance with all the contracting requirements of the City and County of San Francisco.

Estimated Contract Value for FY15-16: \$420,000.00 (Advertising Only)

San Francisco Chronicle is deemed non-responsive as it was submitted past the deadline and not responsible as it does not minimum requirements according to San Francisco Administrative Code Section 2.80 because it is not printed in the City and County of San Francisco.

Advertising Price is sum of Sample Ad A and Sample Ad B pricing for each newspaper.

In the Fiscal Year 2015-2016 Bid Evaluation, *SF Examiner received 29.6 points as their evaluation score. The SF Chronicle received 25.0 points as their evaluation score.* 

The apparent highest score belongs to SF Examiner, with an evaluation score of 29.4 points.

In Fiscal Years 2015-2016 and 2014-2015, the contract was awarded to both the SF Chronicle and The Examiner in 6 month increments. SF Chronicle was awarded the business for the remaining first half of the year after their contract for FY 13-14 was extended by one month, through July 31, 2014, in order to prevent interruption of service. The Examiner was awarded the business for the back half of the year.

Enclosed is the resolution that would designate San Francisco Print Media Co., doing business as the San Francisco Examiner as the City's official newspaper for all advertising for Fiscal Year 2016 - 2017.

The Office of Contract Administration (OCA) received and evaluated two (2) bids for its formal and competitive solicitation, also known as a request for proposal or invitation to bid, for official advertising services. Upon its evaluation, OCA is recommending award to the only responsive and responsible bidder. A "responsive" bidder is one who submits a bid with all required documentation by the due date and time as specified in a solicitation. Additionally, a "responsible" bidder is one who meets all the qualifications and requirements as specified in a solicitation. As seen in the attached table, "Summary of Official Advertising Bids for Fiscal Year 2016 - 2017," the San Francisco Examiner submitted the only responsive and responsible bid for official advertising. The San Francisco Chronicle's bid was non-responsive because the San Francisco Chronicle submitted their bid well past the due date and time. Additionally San Francisco Chronicle's bid was deemed not responsible because it is not printed in San Francisco, a qualification set forth in San Francisco Administrative Code 2.80. OCA policy dictates that we officially recommend only responsive and responsible bidders for contract awards but the Board of Supervisors has historically used its discretion to award the Official Advertising contract to multiple bidders to best serve the City's official advertising needs. Last year, the Board of Supervisors recommended award of the Official Advertising contract to both newspapers, the San Francisco Examiner and the San Francisco Chronicle in 6 month increments.

OCA also formally solicited competitive bids for the services of a clearinghouse in addition to the bids for the official newspaper. The clearinghouse transmits the City's ads to the newspapers and handles invoicing and payment. OCA received one (1) responsive and responsible bid from the Daily Journal Corporation who has been providing clearinghouse services to the City for many years.

The total estimated contract value for official advertising for Fiscal Year 2016 - 2017 is \$420,000.00 and the total estimated contract value for clearinghouse services Fiscal Year 2016 - 2017 is \$63,000.00.

The third and fourth attachments are the Mayor's and Board's versions of San Francisco Ethics Commission Form 126, "Notification of Contract Approval."
